

Solidarity Ministry – European Province – Survey December 2013

The provincial chapter 2013 called for the establishment of a Solidarity Committee.
One of its first tasks was to update the research undertaken in 2011 into Solidarity ministries in the European province.

This survey was designed to help map the activities of this ministry in which confreres participate and to get a picture of the interest and experiences in the province.

It is hoped that by deepening our understanding of the dimensions of Solidarity Ministry, we can continue to be dedicated to this commitment central to our mission for the reign of God.

You find in this document the results of this work and a brief analysis.

Introduction:

In 2011 the 'Excluded and Marginalised' Committee studied in the province, the types of people (*groups*) served by confreres in the solidarity ministry and by which *activities*.

An instrument called a Matrix or grid was used to survey confreres involved in the ministry (cf. below). They were invited to mark "X" in the appropriate square on the grid to indicate (a) the people they serve and (b) by which activity. It was a form of a 'mapping' exercise to get a picture of the number of confreres involved and in which activities. It also revealed the geographical spread of the ministry in each region. The same grid instrument was used to survey confreres in December 2013 to track changes and developments and to see if the issues for the province remain the same so it can continue to support confreres in this ministry. What can the province do with the resources which exist already? The information received does not offer a straight forward comparison with the results of 2011 because many different confreres responded as emphasised in the narrative below, but it proved useful to give a "picture" of the ministry in the province today.

What are the strengths of our situation?


What are the challenges in our situation?





- Caution: The first thing to note is that we received more replies (47) than in 2011 (39) and that only some of those who replied to the earlier research did so this time (27) with 20 being new contributors. This means that direct comparisons are undertaken only with great caution.
- Caution The number of confreres in the province has reduced (-27) since 2011 (273 to 246) and the number of responses is up, so % figures for those involved in solidarity ministry are interpreted with this in mind.
- Replies come from 47 confreres. They could mark "X" in multiple boxes in the Matrix to identify *groups served* and by which *activities*. There was a total of 215 "X"s in the returns.









Remember that figures correspond to the number of times an "X" is marked in that category of *group served*.

- Migrants and Asylum Seekers (20%) is the largest group served, followed closely by Older People (18%).
- The next groups are Families and Youth in Difficulty (12%), Homeless People (12%), those with Disabilities (11%) and then the Sick (11%).
- Parish ministry can be the context in which confreres serve these groups but not exclusively.
- Although the % figure for *Prisons* is small (6%), confreres marked it a significant number of times. This group is served in its own right rather than fitting only into Parish ministry.





Remember that figures correspond to the number of times an "X" is marked in that category of people served.

- Older People, Families and Youth in Difficulty are two groups often served in the course of parish pastoral ministry.
- The group Sick are also frequently found in the same context but it should be noted that older confrères find themselves in a position to minister to this group due to their own circumstances.
- Homeless People figures highly as a group served directly.
- Other Category: see below p.7

From this list it emerges that:


- People with Mental Health Issues is a group served by more than one individual. Although not specified, this can be connected with ministry to Homeless People and Sick.
- The Economically Poor is a group identified and considered not covered by the given categories.
 In both cases activities are in the context of Parish ministry.





- The total number of confreres in the province is 246 and our average age is 72.
- It is of interest to consider the number of confreres involved in the ministry who responded by region, and the size of the region most regions have between 17% and 23% of confreres involved.
- Older confreres continue to be significant in this ministry: 16% - 81 and over, and 31% between 71 and 80.
- The largest number of confreres involved (60%) is in the age range - 61 to 75 - which is to be expected. It is a natural progression in our age profile since 2011.







Average age and number of confreres by region




Percentage of confreres by region in proportion to the number of confreres in the province






- Comparisons of % and numeric figures must be undertaken with caution. Take special note of earlier remark to this effect above (p.3).
- Nonetheless it shows that the group *Migrants* and Asylum Seekers remain a focus of ministry.
- Since we are an aging group, it is natural that older confreres have the opportunity to serve Older People more frequently.
- Ministry to Homeless People and People with Disabilities shows a significant increase. Perhaps this is because of more responses from the confreres or confreres are now recognising the ministry they offer as related to Solidarity.



The percentage of confreres involved - 13% (2011) and 16% (2013) – it needs to be noted that the total of confreres by year (273 in 2011 and 246 in 2013) dropped by 27. So the 16% is a considerable increase and it also might be partially explained by more confreres responding rather than by the development of new ministry involvement.
